Section 4: First-Aid Measures

Evacuate unnecessary personnel. Wear recommended PPE. Contain spillage, absorb with inert material and collect in suitable closed containers for disposal. Prevent entry to drains and watercourses.

Section 7: Handling and Storage

Store in a cool, dry, well-ventilated area. Keep away from heat, sparks, open flames and other ignition sources. Ground and bond containers during transfer.

Section 8: Exposure Controls / Personal Protection

Safety goggles, chemical-resistant gloves and protective clothing. Use adequate ventilation; use respiratory protection if exposure limits may be exceeded.
